

Dear parent/carer,

This is to inform you, that as of Tuesday 15th September, Birmingham is categorised as being at Tier 1 Covid-19 local restrictions.

The only difference to us in school setting is that in the secondary school face coverings should be worn by adults and pupils when moving around the premises, outside of classrooms, such as corridors or communal areas where social distancing cannot be maintained. This does not apply to classrooms.

Therefore, as of Tuesday 15th September we will be requiring all students and staff to wear a face mask in corridors and other indoor spaces as outlined above.

A face covering is considered as additional protection from Covid-19, and not a replacement for effective hand hygiene and social distancing measures. The school has designed the school day and curriculum to ensure that communal contact both inside and outside the buildings is restricted to year group "bubbles" as much as possible, and there are multiple measures in place to protect students and staff.

Face coverings should be plain in colour, and should not include patterns, logos or any writing or emblem that could be considered menacing or offensive. Face covering must be worn properly, covering both nostrils and the mouth. They should not be cumbersome or heavy so that breathing should not be restricted.

Face coverings should be worn in the following circumstances:

- Movement between lessons on corridors
- During social time indoors
- When using toilet facilities

Students will be asked to remove their face masks during lesson times (unless they have a known medical reason to wear one). Face coverings should be kept in a plastic bag in students' pockets when not being worn, and students should clean their hands by washing or with hand sanitiser before putting them on or taking them off. Students must not swap face coverings with each other, and they should not be on desks or surfaces at any time. At this stage, student will not be required to wear face masks outside.

It is essential that students are sensible with regards to this matter, and I would urge parents/ carers to reinforce this with your children. Could I also remind you to reinforce hand sanitising and social distancing with your child whilst he/ she is not on academy premises. Remember; Hands, face, space.
