Dear Parent/Carer

Re: Year 10 Relationship and Sex Education

We believe that promoting the health and well-being of our pupils is an important part of their overall education. We do this through our Personal, Social and Health Education (PSHE) curriculum. This looks at many topics including relationships, both physical and emotional health and living in the wider world.

In line with government guidance, it is important that students have all the information that they need to live a safe and fulfilled life in society.

Therefore, in March we will be looking at the topics of;

- How to stay safe in a relationship
- Peer pressure
- Consent
- Contraception
- The impact of lifestyle choices on relationships

We know that the presentation of sexual images in social and other media makes it important that all young people have a place to discuss pressures, check facts and dispel myths. Even if a child is withdrawn, many pupils will discuss such issues with each other outside the classroom – so, rather than hear about the content second-hand, we hope all pupils will have the opportunity to take part in our carefully planned lessons.

During the lessons pupils will be able to ask questions, which will be answered factually and, in an age-appropriate manner. Each pupil's privacy will be respected, and no one will be asked to reveal personal information.
