- Students should enter via the gate on Griffins Brook Lane (normal student entrance) **We ask for students to arrive by 9.50am to allow time for registration in Elgar Hall Foyer.**
- Normal behaviour policy will apply, students who do not follow the policy will be subject to the normal consequences.
