**RE: Year 9 Boulton and Austin, University of Gloucester Visit – Tuesday 30<sup>th</sup> June 2026**

At Bournville we believe in promoting the highest level of ambition for our students. On Tuesday 30<sup>th</sup> June 2026, 9 Boulton and 9 Austin will be visiting the University of Gloucester. The aim of the visit is to give students an insight into university education and the opportunities that are available to them.
